A disciplinary procedure exists to deal with complaints against members. The APA Council will obtain evidence on both sides and make a ruling. In the first instance, a written warning is given. If a member is found to have transgressed the codes for a second time within a given period, APA may apply various sanctions such as suspension of membership and discussion of the case in APA official mouthpieces. In serious cases, APA reserves the right to:

- expel the member without compensation and publicise the expulsion
- forward the complaint to the Department of Environmental Affairs and Tourism and to the Provincial Registrar of Guides.
